Old Business: Outstanding mowing debts from July 2024. 2 lot owner still need to pay. Those lot owners have been contacted.

- Mowing Dates: (Restrictions Section 3.23) In our restrictions it requires 4 separate mowing dates. Our mowing dates are May 1 (deadline extended to June 1 due to rain), July 1, September 1 and November 1.
 - a. All lots must be mowed within two weeks of the dates listed or the POA can have it mowed and send a statement to the land owner for payment.

Discussion Points:

An idea was brought up to put a portion of the POA funds into a money market account. Research will need to be done on this to ensure it is legal.

Rebecca West asked for us to add the cost of an accountant to the budget.

Claudia Gao asked if the boat dock could be cleaned.

Steve McCarley asked about replacing the keypads at the front gate.

John Lisby asked about having internet installed at the front gate.

Ed Fortuna asked about installing a new keypad at the front gate not just replacing the keys.

Maricella Fortuna asked about dropping the boat slip from the developer.

The question was raised if the POA wanted to purchase the boat slip rights from Tanmai Development and use it as a community slip. Some were for this and others opposed.
